### CHECK LIST

**For each supporting document, original document + 1 set of photocopies should be submitted. [Photocopy of the "Declaration form K" is not required.]**

**Originals (except your Sri Lankan Birth Certificate) will be forwarded to the Department of Immigration & Emigration, Sri Lanka along with your Declaration, and will NOT be returned to you.**

**All Photocopies should be submitted in A4 size. Copies of both sides of each certificate/ card should be submitted. Copies of the bio-data page and the observation page of the passports should be submitted.**

**Translations in lieu of originals NOT accepted.**
